When the emperor Claudius discovered that he was still preaching Christianity from his jail cell, he was executed (270A.D.). In his last letter to the jailer's daughter before his execution, he signed it "From your Valentine", which is where this holiday then got its name.

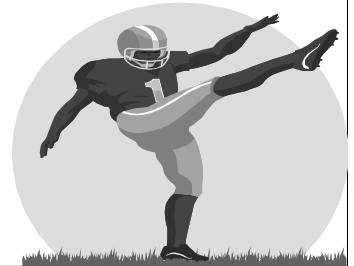

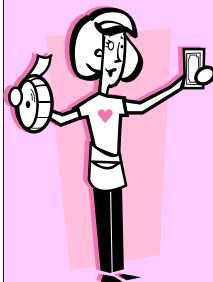

NOMINATIONS WILL BE HELD IN MARCH 2012 SO BE CONSIDERING IF YOU WOULD LIKE TO RUN FOR AN OFFICE OR NOMINATE A QUALIFIED CANDIDATE, ELECTIONS WILL BE HELD IN APRIL 2012 FOR THE UPCOMING FISCAL YEAR JULY 2012 THRU JUNE 2013.

BAR MANAGER: The Bar Manager shall be responsible for the day to day operation of the Foothill Lions Club bar. His/her responsibilities include:

- ⇒ Appoint, train, and schedule all bartenders, who will be responsible to the bar manager and abide **by his/her directions and regulations and they shall have full responsibility, in the manager's ab** sence, for the operation of the bar on their assigned periods of duty.
- ⇒ Collect daily club mail and distribute to the proper person(s).
- ⇒ Unless otherwise directed by the board, he/she shall be responsible for the ordering and re ceiving of all supplies and necessities for the operation of the bar, and submit the bills for same to the club treasurer for prompt payment.
- ⇒ Be responsible for fiscal matters, such as, but not limited to daily cash drawers for the bar. Collection of all monies received in the operation of the bar and delivery of said monies to the club treasurer.
- ⇒ Keep a set of records for expenditures and receipts and man hours used from activities of the bar and report these items to the club treasurer and secretary at the regular board of di rectors meeting.
- ⇒ Responsible for a petty cash fund, not to exceed \$500.00. Said fund to insure adequate cash flow for operation of the bar. Monies used for operation shall be replaced from the proceeds of said operation or event, prior to delivering the proceeds to the club treasurer. He/she shall keep an up to date record of petty cash use and submit a report to the club treasurer at the regular board of directors meeting.

CLUB MANAGER: The Club Manager shall be responsible for the day to day operation of the Foothill Lions Club facility (excluding the bar). His/her responsibilities include:

- ⇒ Ensuring the club building, grounds, and outbuildings are kept in good repair. When maintenance **is required which exceeds the club manager's operating fund (set by the board of directors),** he/she will present to the board an estimate for the work to be performed. If the repairs are of an urgent nature, the club manager shall contact the president and/or vice presidents to re quest a special meeting to approve the expenditure.
- ⇒ Work closely with the bar manager, hall rental coordinator, and grounds keeper to ensure smooth operation of the club. He/she will function as the primary contact for upcoming club, community, and private events to ensure the facility is ready.
- ⇒ Responsible for the routine purchase of consumables used in the club house and kitchen (excluding those used by the Lioness for their fund raising activities).
- ⇒ In the absence of the grounds keeper, the club manager shall coordinate work parties to main tain the grounds and facility as needed.

## Club Manager (continued)

- ⇒ The board of directors authorizes the club manager to spend up to \$500.00 on supplies and maintenance costs without the seeking of prior approval. He/she is required to furnish all receipts and an itemized account of all expenditures monthly to the treasurer.

GROUNDS KEEPER: Although this position is not a member of the Board of Directors, the duties are listed herein due to the importance of the appearance of the facility. His/her responsibilities include:

- ⇒ Responsible for maintaining the grounds and landscaping in good order. He/she will schedule work parties as needed to cut grass, trim, and for general upkeep of the grounds.
- ⇒ Shall work with the club manager to ensure the grounds are ready for scheduled club and private events.
- ⇒ Responsible for upkeep and maintenance of the club mowers, yard tools, and orderly upkeep of the shed.
- ⇒ Authorized by the board of directors, the operating sum of \$100.00 for the purchase of items in pursuant of his/her duties. He/she is required to furnish all receipts and an itemized account of all expenditures monthly to the treasurer.
- ⇒ In the event of a vacancy in the position of Grounds Keeper, these duties will be performed by the Club Manager.

1 Yr DIRECTORS (2) & 2 Yr DIRECTORS (2): Currently the only function these officers hold is to set on the Board of Directors. We are in the process of establishing duties/responsibilities for these positions and once approved by the Board they will be published in the bulletin for the benefit of the General membership.

BOARD OF DIRECTORS:

- A. The members of the board of directors shall be the president, immediate past president, vice presidents, secretary, treasurer, Lion tamer, tail twister, club manager, bar manager, membership director, 1 year directors, and 2 year directors.
- B. Regular meetings of the board of directors shall be held monthly at such time and place as the board shall determine.
- C. Special meetings of the board of directors shall be held when called by the president, or when requested by five (5) or more members of the board of directors, at a time and place as the president shall determine.
- D. The presence in person of a majority of its members shall constitute a quorum at any meeting of the board of directors. Except as otherwise specifically provided, the act of a majority of the board of directors present at any one meeting of the board shall be an act of the entire board of directors.
- E. Duties and Powers: In addition to those duties and powers, expressed or implied, set forth elsewhere in this Constitution and By-Laws, the board of directors shall have the following duties and powers:

Board of Directors (E. Continued)

1. It shall constitute the executive board of this club and be responsible for the execution, through the club officers, of the policies approved by the club. All new business and policy of this club shall be considered and shaped, first, by the board of directors for presentation to and approval by the club members at a regular or special club meeting.
2. It shall authorize all expenditures and shall not create any indebtedness beyond the current income of this club, nor authorize disbursement of club funds for purposes inconsistent with the business and policy authorized by the club membership.
3. It shall have the power to modify, override or rescind the action of any officer of this club.
4. It shall have books, accounts, and operations of this club audited annually or, in its discretion, more frequently and may require an accounting or have an audit made of the handling of any club funds by any officer, committee, or member of this club. Any member of this club in good standing may inspect any such audit or accounting upon request at a reasonable time and place.
5. It shall appoint, on recommendation of the finance committee, a bank or banks for the deposit of funds of this club.
6. It shall appoint the surety for the bonding of any officer of this club.
7. It shall not authorize, nor permit, the expenditures, for any administrative purpose, of the net income of projects or activities of this club by which funds are raised from the public except as authorized by Lions International.
8. It shall submit all matters of new business and policy to the respective standing or special club committee for study and recommendation to the board.
9. It shall name and appoint, subject to approval of the club membership, the delegates and alternates of this club to district (single or sub-multiple) and international conventions.

I apologize for missing the recent passing of **Lion Foster's** Mother, we all are very sorry for your loss and send our condolences.

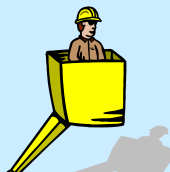
Lion Linda is a new grandma, a **BOY** this time, **Fabian, congrats to the Saala's.**
